### **The House of Saud Must Go**

Ever since it violently created Saudi Arabia (with the help of British money, weapons, advisors, and other forms of aid) at the beginning of the 20<sup>th</sup> century, the House of Saud has been under the protection of Western imperialism. Since the 1940s however, when the Western “responsibility” of protecting the House of Saud was passed from Britain to the US, Saudi Arabia has been virtually an American colony.

Feeling completely protected from the start by its Western masters, the brutal House of Saud has felt free to commit one heinous crime after another against Arabs and Muslims, both in and out of Saudi Arabia. It has not only worked against the interests of its citizens and of most Arab and Muslim countries, but it has also shamelessly served the interests of its imperialist masters in Washington and London on practically all political, economic, and military fronts.

It is no secret that the House of Saud has represented from the onset one of the worst dictatorial ruling houses in the entire world. One does not have to be a genius to figure out either its feudal, corrupt, and totalitarian characteristics, or its contemptible subservient position to the enemies of the Arabs and Islam. Even young and uneducated Arabs and Muslims nowadays know these facts very well.

The grave crimes that the House of Saud has committed are actually innumerable and practically impossible to list in this short essay. Hence, only the most atrocious crimes are mentioned here. These atrocities - which have betrayed most Arabs and Muslims and aroused their deep anger - are classified into the following eleven major crimes, six domestic and five international.

#### **A. The Six Domestic Crimes:**

1. First and foremost, the House of Saud has brazenly deprived the country's citizens of the most important aspect of their dignity and pride, their identity. Hejazis, Najdis, Aseeris, and all other groups and tribes throughout the country have lost their true identities to become “Saudis”. They have become animal-like followers of the House of Saud that has shamelessly named the whole country after itself. This is a demeaning crime without any parallel in the entire world. Actually this crime reflects the true nature of the Saudi feudal system that has turned the whole country into “a family corporation” for the benefits of the House of Saud, which owns practically everything in it including its identity.

2. From the beginning the House of Saud has been committing a major crime against Islam by constantly using it and abusing it to suit its own purposes. It has used Islam not only to obtain and maintain power, but also to terrorize the masses and to keep them in line. Although Islam opposes the monarchy system and requires *Shura* (“democracy”), the House of Saud has established a feudal monarchy that enjoys a total monopoly of power without any mandate whatsoever from the people. No one has ever elected any member of the House of Saud to power. Also, Islamic punishments, such as the beheading of convicted killers or the hand amputation of convicted thieves, are applied mostly to the poor and the working class to cow the masses. All of the 20 some thousand members of the House of Saud (the world’s largest ruling house) are above Islamic and secular laws and do not get punished even though many of them have killed innocent people and have stolen hundreds of millions of dollars in various schemes.
3. Since it bloodthirstily created Saudi Arabia for itself, the House of Saud has been committing one horrible massacre after another in which tens of thousands of innocent people, such as the patriotic Al-Rasheed clan, have been brutally slaughtered. One of the most infamous massacres took place in May 1919 in Tarabah in which over 6,000 Hejazis were savagely butchered in one night. These Saudi terrorist crimes forced at least one million people to run for their lives seeking refuge in the surrounding Arab countries, never to return to their loved ones and properties.
4. There has never been any economic justice in Saudi Arabia. The country’s immense wealth from oil and other resources has been highly concentrated from the beginning in the hands of the House of Saud and its close circles. This enormous inequality in the distribution of wealth has amounted to a major crime against the working classes who constantly struggle to feed themselves and pay their bills. Yet at the same time, well over 95% of the members of the House of Saud (who usually receive free public utilities, Internet, and phone services) are lazy uneducated multimillionaires who have never made an honest living in their lives.
5. Since it assumed power, the House of Saud has been brutally stifling all forms of freedom in the country including the banning of movie-theaters. Unlike the members of the House of Saud who enjoy limitless freedoms in every imaginable area to do whatever they please (including illegal and immoral conducts), the people do not have the slightest freedom of any kind whether political, social, religious, academic, or journalistic. Any opponent of the House of Saud is automatically jailed without trial, and the police use brutal force even against the most peaceful demonstrators.
6. From the outset the House of Saud has turned Saudi Arabia (the holy land of Islam and the birthplace of the Arabs and Islam) into a de facto Western colony where Americans and other Westerners (many of whom are Jews with Zionist tendencies) run the country behind the scene. As a result of this crime, most Americans and other Westerners (many of whom look down on the Arabs and Islam) enjoy in Saudi Arabia some of the highest-paying jobs, free annual round-trip tickets to their respective countries, great

fringe benefits, and living accommodations (often free). Yet at the same time, most of the native people and other Arabs (who sometimes hold the same or even better qualifications than the Westerners) receive the lower jobs usually without fringe benefits or living accommodations.

#### B. The Five International Crimes:

1. Except for some financial handouts to the Palestinians to pacify them once in a while, the House of Saud has done nothing outstanding to defend them or the holy al-Aqsa Mosque against Israel's criminal and illegal policies. On the contrary, the House of Saud has criminally tried several times to sell them out and to liquidate their cause in order to please its Western masters who created Israel. Like a few other Arab countries under Western influence, Saudi Arabia has also made several illegal secret contacts with Israel, the eternal bitterest enemy of Arabs and Muslims. Moreover, under orders from its Western masters, the House of Saud has shamelessly tried behind the scene to pressure several Arab countries not only to break the Arab economic boycott of Israel, but also to recognize Israel and establish diplomatic relations with it.
2. The House of Saud has treacherously and shamelessly helped its imperialist masters in Washington and London to illegally invade and destroy both Afghanistan and Iraq where hundreds of thousands of innocent Arabs and Muslims have been brutally killed by the invading Western armies. This heinous crime, which has deeply disturbed most Arabs and Muslims, clearly violates the basic Islamic teachings that are emphasized many times in the Holy Qur'an and the Hadith.
3. From the beginning Saudi Arabia has used its position in the Arab League to sabotage Arab integration and Arab unity to render the League ineffective in order to please its Western masters. This Saudi crime against the Arab nation has also included passing even the most secret deliberations of Arab Summits to the US, which in turn automatically passes it to Israel. The House of Saud has always opposed Arab nationalism and any left-wing Arab leader who courageously stands up to Israel or the imperialist West. For example, in cooperation with the CIA and ARAMCO in the late 1950s and early 1960s the House of Saud paid over 12 million British pounds in bribes to assassinate President Jamal Abdul-Nasser and to break up the United Arab Republic (the 1958-1961 union between Egypt and Syria).
4. Much to the detriments of the member-states of OPEC (Organization of Petroleum Exporting Countries) the House of Saud has used Saudi Arabia's leading position in it to sabotage its policies and operations in order to please its American masters. Because 10 of OPEC's 11 member-states are Muslim (7 of which are Arab), this Saudi crime has in fact harmed the economic interests of the Arab and Muslim countries whose only power is oil. Even Venezuela (the only non-Muslim country in OPEC) has never stooped to such despicable betrayal of the oil cartel.
5. The House of Saud has worked secretly with its American masters and Israel in targeting left wing and revolutionary groups in developing nations. Saudi Arabia has

made several large financial contributions to many of the US illegal and immoral wars against revolutionary movements throughout Asia, Africa, and Latin America. For examples, in the 1980s Saudi Arabia supplied the CIA with tens of millions of dollars for its destructive war against the revolutionary Sandinistas in Nicaragua. This Saudi crime against poor nations around the world has caused death and misery to millions of people who have been trying to escape American control and exploitation.

There is no doubt that the above 11 horrendous crimes would require the immediate removal of the House of Saud from power, and the arrest of its leading members to be put on trial for high treason to the country's citizens, Islam, Arabism, and many other non-Muslim developing nations around the world.

The feudal House of Saud has neither the desire nor the capability to stem its own treacheries, crimes, and corruption. The overwhelming majorities of the country's citizens and those of other Arab and Muslim countries detest the House of Saud, feel ashamed of it, and wish for its prompt disappearance. In fact, the above abhorrent crimes have united the country's two ideologically opposing camps against the House of Saud: the left-wing Pan-Arab nationalists, and the right-wing Islamic fundamentalists.

In short, the dictatorial House of Saud has severely pained and shamed most of the country's citizens, the Palestinian people, the Arab nation, the Muslim world, OPEC member-states, and many other developing nations around the world. If the House of Saud is allowed to stay in power any longer, it will continue to commit more outrageous crimes; most Arabs and Muslims in and out of "Saudi" Arabia will soon suffer more miseries and more humiliation and their political, economic, and social problems will vastly increase. Accordingly, the House of Saud must go, and must go now!
